Periodic Investor Report for the Relevant Period from July 1, 2019 to December 31, 2019 (the Relevant Period or the Second Half of 2019)

Reference is made to the Common Terms Agreement dated October 15, 2019 between, *inter alia*, Società di Progetto Brebemi S.p.A. as the issuer (the **Issuer**), the Note Trustee and the Facility Agent (the **CTA**). Capitalised terms not defined herein shall be construed in accordance with, and have the meaning given in, the CTA or the Master Definitions Agreement (as defined in the CTA).

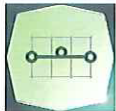
Further to Clause 5.6 (Periodic Investor Reports) of the CTA, this report contains:

(i) Maintenance Liabilities

The Maintenance Liabilities actually incurred in the Relevant Period, which are related to the O&M Contract entered into between the Issuer and the O&M Contractor, amounted to Euro 10.184.796 and are substantially in line with those forecasted in the Base Case Model equal to Euro 10.234.161.

(ii) Other Liabilities

The other Liabilities actually incurred in the Relevant Period amounted to Euro 5.948.581 and are substantially in line with those forecasted equal to Euro 5.561.068, as further detailed below.

(iii) Level of Tariffs

During the Relevant Period, the Tariff rates (net of VAT and the ANAS surcharge¹) have not changed compared to those disclosed in the Listing Particulars. The table below details such Tariff rates.

Furthermore, on October 24, 2019, the Issuer submitted to the Grantor a request to adjust the 2020 Tariffs of 3.79%, on the basis of the formula provided for in the Concession Agreement and set out below:

$$\Delta T = \Delta P - X + K = 0,8\% - (-2,99\%) + 0,000\% = 3,79\%$$

Where:

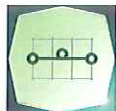
ΔT: represents the annual variation percentage of the tariff rate;

ΔP: represents the expected inflation rate (as set out in the PEF as then in effect);

X: represents the annual tariff adjustment percentage factor determined at the beginning of each regulatory period and not subject to change within such period. In the current Financial Regulatory Plan (*piano finanziario regolatorio*) (**PFR**), the tariff increase for each year has been computed with an X factor equal to 2.99% (until 2038);

K: represents the annual tariff variation percentage determined each year in order to allow the remuneration of investments made the year preceding the year of application. In the current PFR, the tariff increase for each year has been computed with a K factor equal to zero as no investments have been made;

¹ Law No. 102/2009 and Article 15, paragraph 4 of Law Decree No. 78/2010 provide for the ANAS Surcharge which is charged to the motorway concession holder and is recovered from users of the motorway by applying an equivalent increase in tariffs. The ANAS Surcharge is calculated on the basis of the distance in kilometers for each vehicle that uses the motorway infrastructure (equal to six thousandths of a Euro (€0.006) per kilometer for toll classes A and B and equal to 18 thousandths of a Euro (€0.018) per kilometer for toll payment classes 3, 4 and 5). As such, the ANAS Surcharge is a pass-through item.



By means of the Inter-Ministerial Decree dated December 31, 2019, the Ministry of Infrastructure and Transport, in consultation with the Ministry of Economy and Finance, established a tariff increase of 3.79% starting as of January 1, 2020.

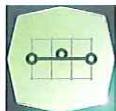

During the Relevant Period, only one material insurance claim under the All Risk Property Insurance was made. Such claim referred to a meteorological event, occurred on August 7, 2019, which affected the provinces of Bergamo and Brescia and caused damage to the Calcio toll booth for an estimated value of approximately Euro 170.000.

(vii) Description of Claims

On December 16, 2019, the Issuer received a notice from the Grantor relating to (i) an alleged delay in completing the Brebemi road works within the agreed timeline, and (ii) the application of a related penalty of €1,000,000, which would be applied in the context of the PEF update, by deducting the relevant amount from the admitted costs (therefore without any cash payment). On 31 January, 2020, the Issuer submitted its response highlighting the illegality of the penalty, requesting the cancellation of such penalty by no later than February 28, 2020 and reserving its right to challenge it. On February 27, 2020, the Grantor confirmed the application of the penalty. On 27 February the Grantor confirmed the application of the penalty. The Company has appointed a counsel to contest the allegations.

There are no updates relating to the ANAC 2018 Resolution other than those previously disclosed in the Listing Particulars.

There are no pending proceedings and no penalties have been imposed pursuant to the provisions of Legislative Decree 231.

La mobilità sulla rete autostradale a pedaggio rilevata nel trascorso mese di settembre, in raffronto con quella dello stesso periodo del 2018, si è distinta per un buon miglioramento relativo alla componente veicolare pesante stabilizzatosi su un incremento pari al 3,6% mentre per quanto riguarda il settore dei veicoli leggeri quest'ultimo ha subito un lieve calo che sebbene abbia comportato qualche riflesso sul dato complessivo non è tuttavia stato tale da indurne un esito negativo. La combinazione di tali fattori ha infatti portato ad un livello di traffico mensile di poco superiore al pareggio e ad un aumento del dato relativo al

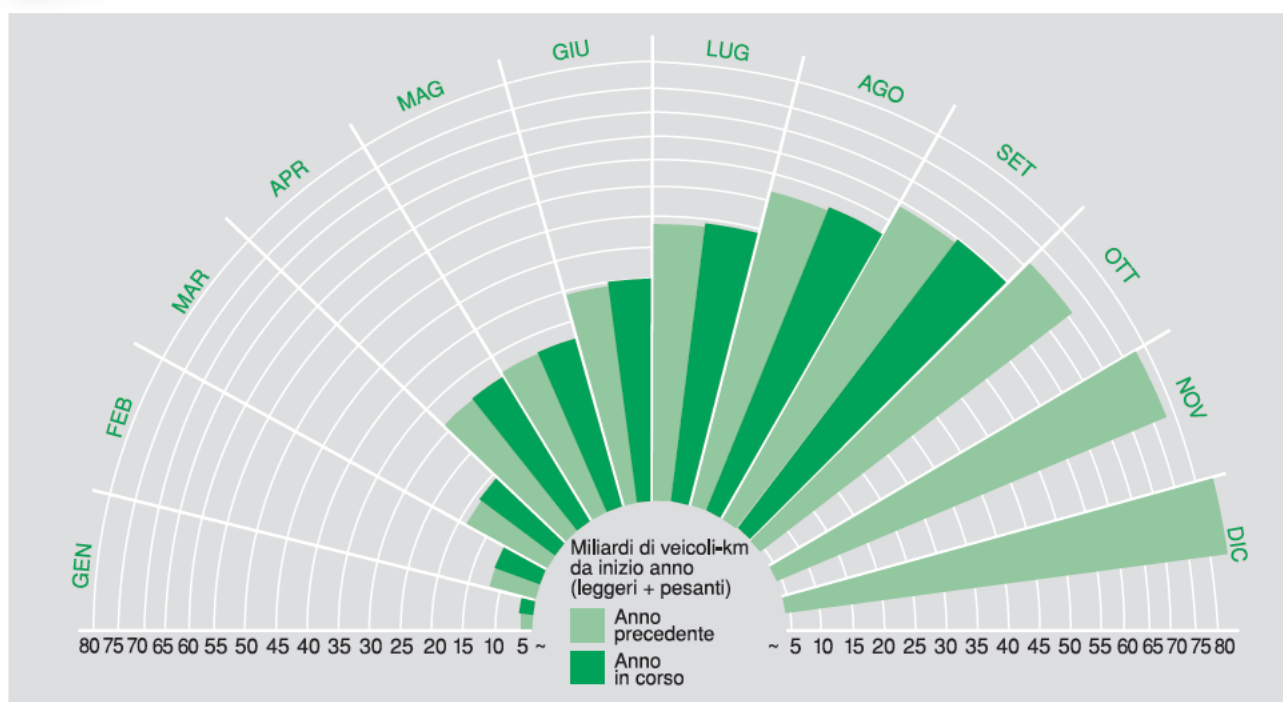
cumulato annuale di mezzo punto percentuale. Globalmente, quasi sessantacinque miliardi di veicoli-km sono stati percorsi sulla rete da inizio anno, con uno scarto in positivo valutabile nello 0,5% rispetto al risultato ottenuto nel terzo trimestre 2018.

Passando ora alla disamina degli elementi attinenti la sicurezza stradale, nonostante il periodo abbia rimandato un modico aumento del tasso di incidentalità, dall'altra parte assistiamo a dati assolutamente favorevoli nella totalità dei rimanenti campi, con decrementi rilevanti soprattutto per quanto riguarda i settori

concernenti la mortalità (- 9,8 % nel tasso relativo agli eventi con conseguenze mortali e - 8,6 % in quello del numero di decessi). Quanto sopra, a riprova del sempre costante impegno profuso dalle società concessionarie nel settore della sicurezza e del pronto intervento, con procedure tempestive ed efficienti in caso di incidenti sulle tratte da loro gestite.

Tassi degli ultimi dodici mesi - (Numero x 100 milioni di veicoli - km)



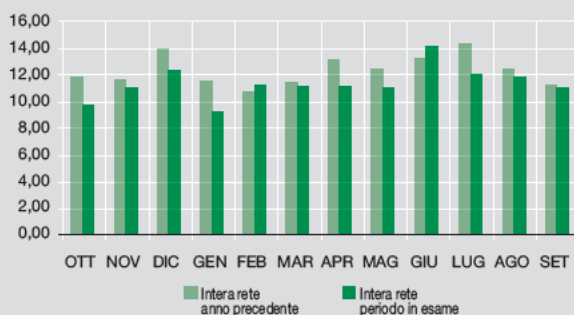
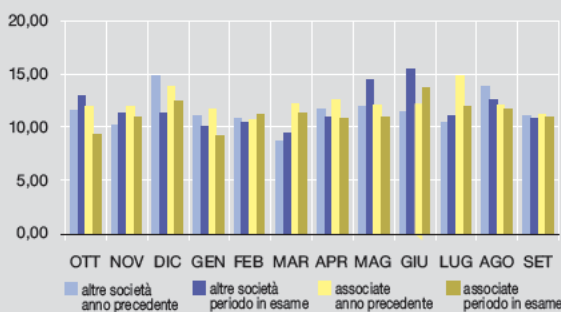

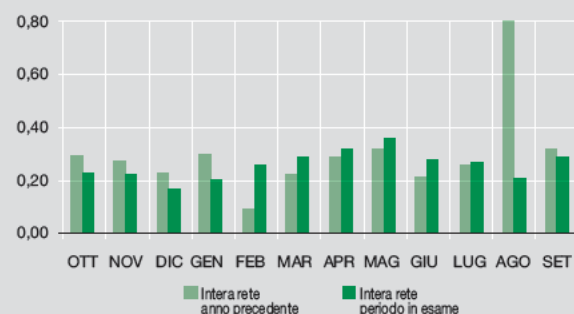
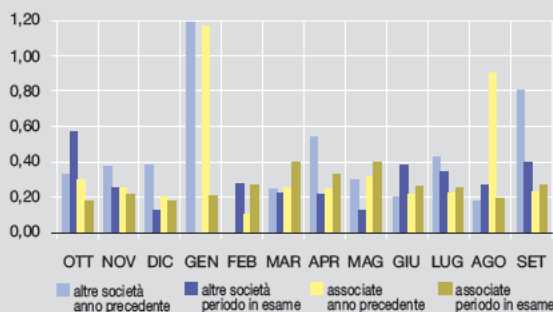
