Periodic Investor Report for the Relevant Period from 1 July 2021 to 31 December 2021 (the Relevant Period or the Second Half of 2021)

Reference is made to the Common Terms Agreement dated 15 October 2019 between, *inter alia*, Società di Progetto Brebemi S.p.A. as the issuer (the **Issuer**), the Note Trustee and the Facility Agent (the **CTA**). Capitalised terms not defined herein shall be construed in accordance with, and have the meaning given in, the CTA or the Master Definitions Agreement (as defined in the CTA).

Further to Clause 5.6 (Periodic Investor Reports) of the CTA, this report contains:

(i) Maintenance Liabilities

The Maintenance Liabilities actually incurred in the Relevant Period, which are related to the O&M Contract entered into between the Issuer and the O&M Contractor, amount to Euro 10,610,200 substantially in line with the forecast of Euro 10,688,574.

(ii) Other Liabilities

The Other Liabilities actually incurred in the Relevant Period amount to Euro 5,898,284, slightly higher than the forecast of Euro 5,551,768, as further detailed below.

The main changes were recorded in (i) the "Other toll roads costs" line item, due to the increase in energy costs that occurred in the last months of 2021 and (ii) the "Fee and other costs" line item, which mainly consisted in Concession Fee costs, calculated as 2.4% of net toll revenues.

(iii) Level of Tariffs

Below are the rates per vehicle class, net of VAT and ANAS surcharge, applied since 1 January 2021:

In the Relevant Period, no tariff changes have occurred, and the Issuer has not requested any adjustment in tariffs.

On 11 October 2021, the Issuer requested Concessioni Autostradali Lombarde S.p.A. (the **Grantor**) to adjust the toll rates for 2022 to 4.49%, based on the conventional tariff formula.

However, in a note dated 31 December 2021, the Ministry of Transport and Sustainable Mobility informed the Grantor that *"the tariff adjustment requests made by the concessionaires BreBeMi S.p.A. and Pedemontana Lombarda S.p.A. were assessed but considered as not acceptable due to the lack of the regulatory prerequisite consisting in the existence of a current economic and financial plan"* and that *"upon effectiveness of a new economic and financial plan, such companies may recover any tariff adjustment accrued from the beginning of the current regulatory period"*.

Subsequently, on 28 February 2022, an appeal against the above mentioned decision of the Ministry of Transport and Sustainable Mobility was filed with the Regional Administrative Court of Lazio, as it is deemed to be detrimental to the Issuer's interests and rights.

As described in the previous Investor Report, with Resolution no. 16/2019 dated 18 February 2019, the Transport Regulation Authority (**ART**) initiated a consultation procedure aimed at defining a toll tariff system based on the price-cap method with determination of the productivity indicator X at five years.

Following such consultation procedure, the ART adopted specific resolutions for each concessionaire that is in the process of updating its economic and financial plan, such as the Issuer. As a result, on

17 June 2021 the ART issued Resolution no. 87/2021 (**Resolution 87/2021**) that sets out a new toll tariff system for the Issuer in which the toll tariff comprises:

(i) a "management tariff", intended to assure the recovery of operating costs and capital costs (amortization and remuneration) of non-reversible assets, and (ii) a "construction tariff", aimed at allowing the recovery of capital costs (depreciation and remuneration) relating to reversible assets.

Moreover, Resolution 87/2021 also (i) provides for a safeguard mechanism aimed at ensuring that concessionaires recover capital costs relating to investments that have already been made or that are yet to be made (if these have already been contracted / entrusted at the date of publication of the resolution), in compliance with the level of profitability deriving from the application of the previous tariff system and (ii) sets the tariff principles and criteria relating to any continuation of operations beyond the expiry of the concession.

On 16 September 2021, a petition was filed with the Regional Administrative Court of Piedmont against Resolution 87/2021.

With a ruling dated March 31, 2022, the Regional Administrative Court of Turin partially accepted Brebemi's appeal regarding the WACC methodology to be applied in relation to the remuneration of the new investments (if any).

(iv) Traffic Figures for Light and Heavy Vehicles

The following table is a summary of the traffic figures for light and heavy vehicles recorded for the Project in the Relevant Period compared to the PEF forecast set out in the Semi-Annual Financial Model.

Although during the first half of the year restrictions on mobility were still in place, the volume of traffic on the motorway showed a gradual recovery over the course of the year and the traffic volumes recorded for heavy vehicles was higher than the volumes recorded in 2019, hence before the Covid-19 pandemic.

No Default or Financial Ratio Breach has occurred and is continuing as at the date of this Periodic Investor Report. A Distributions Lock-Up has occurred and is continuing as at the date of this Periodic Investor Report. The Distributions Lock-up has been triggered by the lower economic and financial performance of the Issuer which are a direct result of the restrictions imposed in connection with the Covid-19 pandemic.

(xv) Junior Notes Interest and Principal paid

For the period from (and including) the Issue Date to (and including) the last day of the Relevant Period, the Issuer paid Euro 7,671,141.36 of interest and repaid Euro 5,253,844 of principal amount in respect of the Junior Notes corresponding to interest and principal due on 31 December 2019 and 30 June 2020.

With respect of the Junior Notes, as a result of the application of the Restricted Payment Condition, at the Interest Payment Date of 31 December 2021, the Issuer did not pay the relevant Interest Amount, equal to Euro 5,723,718.26 and the related Principal Amount, equal to Euro 3,473,748

This is because the Issuer elected to exercise its option to capitalize the relevant PIK Interest Amount in accordance with the Finance Documents.

As of 31 December 2021, the Principal Amount Outstanding of the Junior Notes remains equal to Euro 177,735,190.86.

The Interest Amount unpaid on 30 June 2021, equal to Euro 5,449,357.01, has been capitalized with effect from 1 January 2022.

(xvi) PEF Rebalancing

In October 2021, the regulatory concession period which began in October 2016 expired.

Pending the formal start of the updating and rebalancing procedure, provided for under Article 11 paragraph 7 of the Concession Agreement, the Issuer, also with the support of external advisors, began all preparatory activities required to initiate negotiations with the Grantor for the rebalancing of the economic and financial plan.

On 1 April 2021, negotiations with the Grantor began and the required documentation was exchanged. In the following months, several meetings were held with the Grantor with the aim of reaching a shared position on the economic and financial plan.

Notwithstanding the fact that the Issuer does not agree with the Grantor's position on certain parameters of the new economic and financial plan, among which the most relevant concerns the WACC rate on invested capital, a formal rebalancing proposal was shared with the Grantor on 23 December 2021. Such proposal contemplated an extension of the duration of the Concession Agreement and included a new traffic study that took into consideration the changed macroeconomic framework.

On 31 January 2022, the Grantor rejected such proposal (the **Grantor's Rejection Decision**), but then the Issuer and the Grantor agreed on the key items of the rebalancing process on 10 March 2022.

However, in light of the fact that a possible agreement it's not fully defined and it's subject to several approvals that would have exceeded the deadline by which the Grantor's Rejection Decision could have been challenged, the Issuer informed the Grantor that a litigation procedure would have been lodged before the competent Court as a protective measure.

The Grantor's Rejection Decision was referred to the Civil Court of Brescia on 4 April 2022.

(xvii) Credit Rating

On 9 June 2021, DBRS Morningstar confirmed the Issuer rating and the "Senior Secured" debt rating of Società di Progetto Brebemi S.p.A. at the "BBB (LOW)" level with a Negative Trend. In addition, DBRS Morningstar also removed the rating from "Under Review with Negative Implications".

On 5 October 2021, Fitch Rating announced that the "Senior Secured" class A1, A2 and A3 debt rating of Società di Progetto Brebemi S.p.A., has been confirmed at the "BB+" level a Stable Outlook.

Traffico e Sicurezza



In Breve

Dall'esame dei dati raccolti nel mese di dicembre si evidenzia una continua crescita su tutti i valori di traffico, raddoppiati, sostanzialmente, rispetto ai livelli esistenti durante l'analogo periodo dell'anno precedente. Più nel dettaglio, i veicoli leggeri si sono attestati con un valore di gran lunga superiore rispetto al mese di dicembre 2020, con un tasso differenziale del +74,1% frutto delle limitazioni agli spostamenti territoriali che erano in vigore in quel tempo, mentre per i veicoli pesanti (i quali non hanno invece mai subito grandi contenimenti alla circolazione durante la pandemia) si nota un aumento maggiormente contenuto, ma sempre soddisfacente pari al +13%. Nel calcolo totale dei

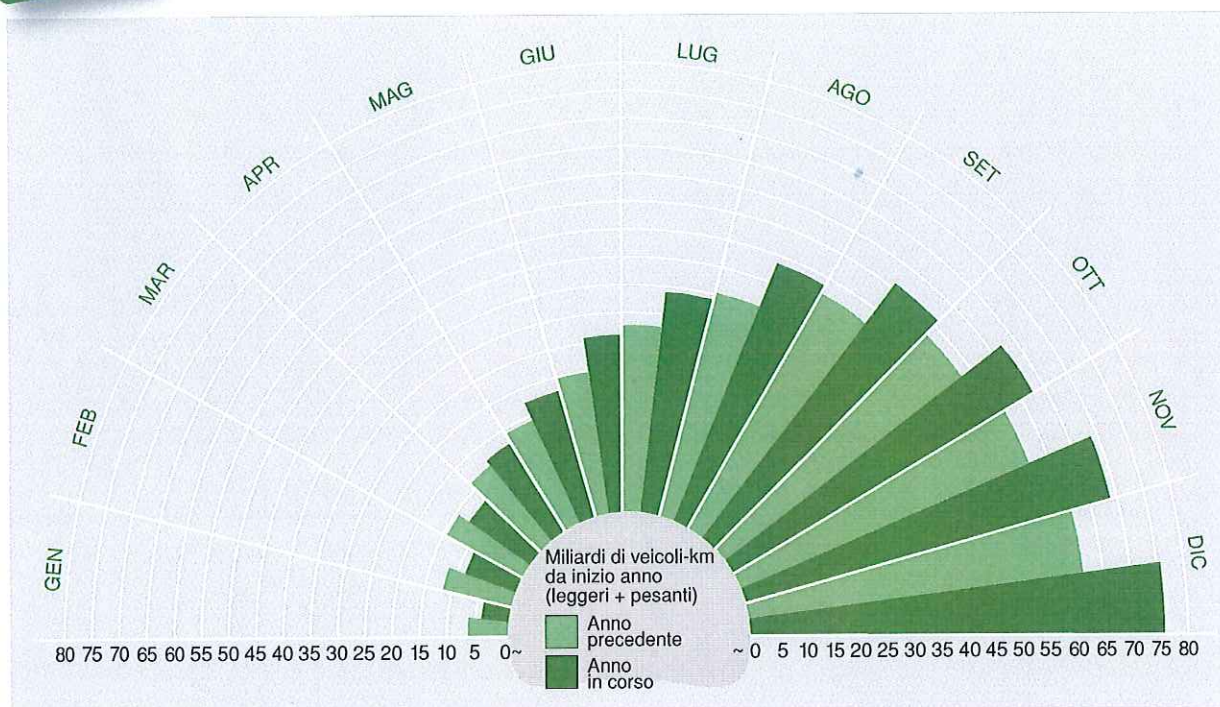
veicoli registrati da inizio anno, si riportano i valori analizzati: settantacinque miliardi e mezzo di veicoli/km sono stati percorsi sulla rete autostradale a pedaggio, ovvero circa quattordici miliardi in più del 2020 (una percentuale equivalente sostanzialmente al trenta per cento, mentre il confronto con il periodo precedente alla pandemia relativo all'anno 2019 si attesta ancora su un risultato negativo del -10,8%).

Rivolgendoci ora all'analisi dei dati relativi alla sicurezza stradale su tutta la rete, si nota come essi abbiano evidentemente risentito la notevole differenza tra i volumi di traffico registrati negli esercizi di riferimento, qui in confronto: si nota infatti

un generalizzato incremento di tutti gli indici coinvolti, sebbene bisogna comunque sempre tener presente che le percentuali restituite – per quanto piuttosto elevate in apparenza come nel caso di quella concernente la mortalità – sono dovute anche alla relativa esiguità dei numeri assoluti in questione.

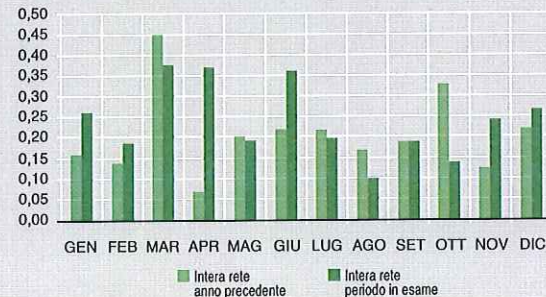

Tassi degli ultimi dodici mesi - (Numero x 100 milioni di veicoli - km)



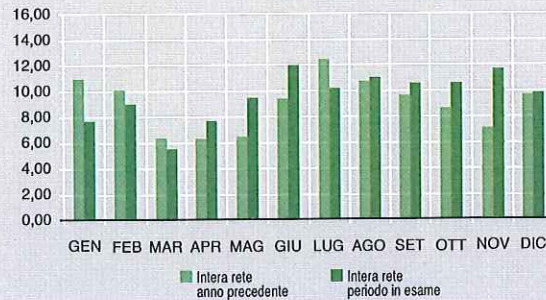
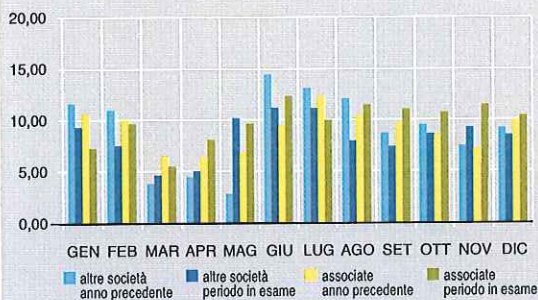

Tassi degli ultimi dodici mesi - (Numero x 100 milioni di veicoli - km)



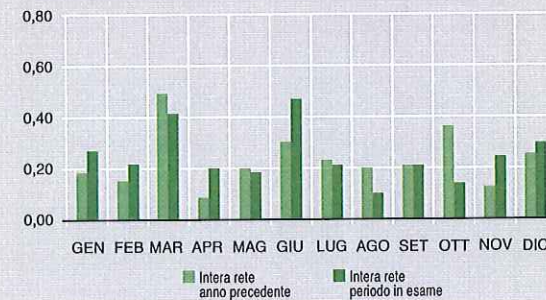
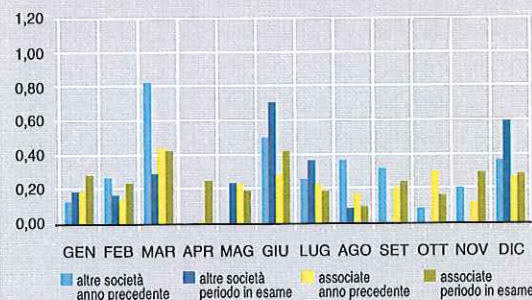
